

**UNION COMMUNITY SCHOOL DISTRICT
DYSART-GENESE0-LA PORTE CITY
Special Board Meeting
June 4, 2021**

Call to Order and Take Roll:

The special meeting of the Board was called to order by Board President Kevin Sash at 5:02 pm. Roll call was taken and the following board members were present: Corey Lorenzen, Brandon Paine, Ben Schemmel, and Jenna Scott. Absent: Darrell De Winter and Kristi Martin.

Agenda:

On a motion by Schemmel, seconded by Lorenzen, the board approved the agenda as presented. Motion carried 5-0.

Approve 2020-2021 Teacher Master Contract:

On a motion by Schemmel, seconded by Scott, the board approved the 2021-2022 teacher master contract. The contract includes a \$1,700 increase per FTE (including FICA/IPERS) and coaches/sponsors receiving their annual increase per the current schedule. Motion carried 4-0-1, with Lorenzen abstaining.

2021-2022 Support Staff Contracts:

Supt Fleshner and the board's negotiation team of Sash and Paine reviewed and recommended the following salary increases: building secretaries, \$0.70/hour; teacher associates/aides/transportation aides, \$0.70/hour; bus drivers, \$0.70/trip; custodians, \$0.70/hour; and food service support staff, \$0.70/hour. Individual changes include Transportation, Grounds, & Maintenance Director Mike Timmer moving to salary position of \$75,000, MS Head Cook Cara Glenn moving to \$15/hour and Food Service Director Tina Hanna moving to \$21.50/hour.

On a motion by Lorenzen, seconded by Scott, the board approved the FY2021-2022 support staff contracts as presented. Motion carried 5-0.

2021-2022 District Office and Administration Contracts:

Supt Fleshner and the board's negotiation team of Sash and Paine reviewed and recommended the following salary increases: an increase of \$2,000 for the business manager and an increase of \$1,500 for administrators.

On a motion by Schemmel, seconded by Lorenzen, the board approved the recommended increases as presented. Motion carried 5-0.

2021-2022 Preschool Teachers and Associate Contracts:

Due to the expanding preschool programs in Dysart and La Porte City beginning in the 2021-2022 school year, these contracts will move to 1.0 FTE contracts for the preschool teachers and the preschool associates.

On a motion by Lorenzen, seconded by Schemmel, the board approved the 1.0 FTE contracts for preschool teachers and preschool associates. Motion carried 5-0.
